

DEXUS STANDARD COMPETITION TERMS & CONDITIONS

80 Collins / MFWF Instagram Competition Terms and Conditions

1. These terms and conditions are for all entrants who enter the MFWF Instagram Competition Centre Promotion ("Promotion"). Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The "Promoter" is Dexus Wholesale Management Limited (ABN: 56 159 301 907) as Trustee for 80 Collins Street Trust (ABN: 79 004 749 927). The address is 80 Collins Street, Melbourne, VIC 3000.

ELIGIBILITY

3. Subject to condition 3, this Promotion is only open to Australian residents aged 18 years or over.
4.
